

## **Schedule of Boundaries M.C. Ellenabad**

- Ward No. 01 (Reserved for Scheduled Caste Women) :- Starting from the point of Western and northern side of Municipal Committee and going alongwith northern side of M.C. limit intersecting by Talwara Road, thereafter going alongwith the above said road up to the Junction of Firni Road, thence going alongwith above said road & street Ganga Mai Dharmshala Wali to Junction of Govind Ram Lakkar Wala, thence going alongwith above said house to Junction of Regran Wali street, thence going alongwith above said street to Junction of Hanumangarh Road, thence going alongwith the above said street up to the Junction of Firni Road, thence going alongwith the above said street point up to Hand pump (Near Canal) and going up to western side of Municipal Limit thence going along-with above M.C. Limit meet up to Northern M.C. Limit, Which is the point of start.
- Ward No. 02 (Reserved for Scheduled Caste Women) :- Starting from the Junction of Gangamai Dharmshala & Firni Road, going alongwith street to Junction of Street Goran Wali, thence going alongwith the above said road to Junction of Radheyshayam Patwari House, thence going alongwith above said house & House of Mahesh Bhargva to Junction point of Street Goga Medi Wali, thence going alongwith above said road & House of Lalchand Khatik to Junction of Street, thence going alongwith above said road & House of Vijay Dipo wala to Junction of street Regran wali, thereafter going alongwith above said street & Govind Ram Lakkar Wala to Junction of Street Ganga Mai Dharmshala, thence going alongwith above said road to Starting point Junction of Street Gangamai Dharmshala & Firni Road, Which is the point of start.
- Ward No. 03 :- Going alongwith from starting point i.e. Junction of Street Goran Wali & Firni Road to Junction Tibbi Chowk, thereafter going along-with above said road to Junction of Devilal Chowk, thence going alongwith above said chowk to with Hanumangarh Road to Junction of Street Regran Wali, thence going alongwith in this road & House of Vijay Dipo wala to

Junction of Street, thence going along-with in this road & House of Lalchand Khatik to with Junction of Street, alongwith H/o Lalchand Khatik point alongwith street of Gogamedi up to the Junction of Mahesh Bhargava, thereafter going alongwith from house of Radheyshayam Patwari to Junction of Street Goran Wali, thence going alongwith above said road to Starting point Junction of Street Firni Road & Street Goran Wali, Which is the point of start.

- Ward No. 04 :- Going alongwith from starting point i.e. Junction of Tibbi Chowk & Firni Road to Bijli Board to House of Brijlal & Junction of Bijli Board, thereafter going along-with above said house to Junction of Street Old Kothi, thence going along-with above said road to Pareek General Store and Pareek General Store to House of Roopram, thence going alongwith left side street of Dalip Soni to Junction Firni Road, thence going along-with above said road to Jain Dharmshala to Gourav Kiryana Store, thence going alongwith choraha to House of Karnail Singh, thence going alongwith above said house to House of Kanhiya Lal, thereafter going alongwith above said house to Main Bazar Road and above said road to Tibbi Stand, Which is the point of start.
- Ward No. 05 :- Starting from the point where Northern side intersecting by Talwara Road and going alongwith M.C.limit to meet the front point of Beauty Tailor, in this street Junction of House Kala Singh Driver, thence going alongwith above said road to House of Bansilal, thence going alongwith Junction to house of Kumar Tailor, thence going alongwith above said road to Junction of Talawara Road, thereafter going alongwith above said road to point of where meet the Northren side, Which is the point of start.
- Ward No. 06 :- Going alongwith from starting Junction i.e. Bijli Board road and Street of house Kumar Tailor to house of Bansilal, thence going alongwith above said road & house of Kala Singh Driver to Junction of street Beauty tailor, thence going alongwith above said road to the point of where meet the Eastren side of M.C. limit, thence going alongwith above said side to Junction of point i.e. Pareek Kiryana Store, thence going alongwith Old

- Kohti road to Junction to front of street house of Brij Lal street, thence going alongwith Bijliboard road to House of Kumar Tailor, Which is the point of start.
- Ward No. 07 :- Going alongwith from starting Junction i.e. Bijli Board road and street of house Vaid Daleep Soni to house of Banwari Lal, thence going alongwith above said point to front street of Pareek Kiryana Store & going alongwith Pareek Kiryana Store to Eastren side of M.C. Limit to going from this point to Southen side of M.C. limit Mameran Road, thence going alongwith above said road to Satreet of Gurudawara & going alongwith Junction of Mameran Road to Junction of Street Dr. Pal, thence going alongwith above said road to Junction of Bijli board road, thereafter going on the road of Bijli board to Junction of Street Vaid Daleep Soni house, Which is the point of start.
  - Ward No. 08 :- Going alongwith Devilal chowk, Gurudwara Road to House of Prem Nagpal, thence going alongwith above said road to house Pritam Singh, thereafter going alongwith above said house to Junction of house Karnail Singh, thence going alongwith above said road to Junction of front street of Gourav Kiryana store, thence going alongwith above said road & street of Jain Dharmshala to Junction of Bijli Board Road, thence going alongwith above said road to Junction of Police Station Road, thereafter going alongwith above said road to Devilal Chowk, Which is the point of start.
  - Ward No. 09 :- Starting from junction i.e. street Dhani Deshraj and Hanumangarh Road and going alongwith this road to Junction of Main Bazar, thence going alongwith above said Bazar to Junction of street Bhadu Wali, thence going alongwith above said road to point of front street of Temple of Ramdev, thence going alongwith above said street to point of front street of Hanuman Nai, thence going alongwith above said road to front the point of Sh. Banwari Talwaria, thence going alongwith above said road to Junction of Dhani Deshraj, thereafter going alongwith above said road to Junction of Hanuamangarh road, Which is the point of start.

- Ward No. 10 :- Starting from Devlal Chowk to alongwith Police station road to Junction of Bijli board road, thence going alongwith bijli board road to Namste Chowk, thence going alongwith above said chowk to on Mameran road to Junction of Lovely Sweet house, thence going alongwith above said point to Devlal Chowk, Which is the point of start.
- Ward No. 11 :- Starting from Main Bazzar, Mameran chowk & going alongwith above said road to Kutiya wali road and going alongwith above said road to Junction of Street Kutia wali, thereafter going alongwith above said road to point of front side of Hari Singh Khod, thence going alongwith above said road to Junction of Sirsa road, thence going alongwith above said road Junction of Main Bazar road, thence going alongwith above said road to Junction of Mameran road, Which is the point of start.
- Ward No. 12 :- To Firni Bijli Board road, Starting from junction of Dr. Pal and going alongwith Dr. pal to Junction of Kabir Mandir, thereafter going alongwith street of Gurudwara wali up to front point of Mameran road, thence going alongwith above said road to Junction of Shop of Mahender Mistri, thence going alongwith above said road up to Junction point of House of Verma Sabji Wala, thence going alongwith above said road to Junction of with the street of house of Kuldeep Singh Namdhari, thence going alongwith above said road to Junction of Sirsa road, thence going alongwith above said road to Junction of shop of Makhan singh, thereafter going alongwith street of Mama Bhanja to Junction of Mameran road, thereafter going alongwith mameran road to Junction up to point of Namste Chowk, thence going from above said junction to Firni and Firni to Bijli board road & Junction of Street Dr. Pal, Which is the point of start.
- Ward No. 13 :- Starting from junction i.e. street of Mahender Mistri, Mameran road & going alongwith above said road to point of where intersecting the Eastren side of M.C. limit, thence going alongwith above said side point from where intersecting the Southern side of M.C. limit, thence going alongwith above said southern side to the point of house of

Chhinda Driver, thence going alongwith above said house to Bus Stand Sirsa road, thence going alongwith above said road to Junction of street Harlal Secretary, thence going alongwith above said road to Junction of house Surjeet Master, thence going alongwith above said road to point of the front side up to house of Kuldeep Namdhari, thence going alongwith above said road to front side of house Verma Sabji Wala, thereafter going alongwith above said road to Junction of Shop of Mahender Mistri & Mameran road, Which is the point of start.

- Ward No. 14 :- Starting from Sirsa road Bus stand & going along of Southern M.C. Limit, thence going alongwith above said point & going up to Western side of M.C. Limit to Nohar road, behind of Additional Anaj Mandi, thence going up to Nohar road side of Harchand ka Bass main road front side of Ramdev Mandir coming from Vishwkarma Mandir to Junction up to Sirsa road, thence going alongwith above said road to Bus Stand Sirsa road, Which is the point of start.
- Ward No. 15 :- Starting from Railway crossing Nohar road & going alongwith Railway track up to point where intersecting by Western M.C. Boundary, thence going alongwith above said M.C. boundary side to point where it intersecting by Southern side of M.C. Limit, thence going alongwith above said boundary a point where it intersected by Eastern side of M.C. limit, thence going alongwith Eastern side upto point where situated Additional Anaj Mandi, thereafter alongwith Nohar road to Junction of Anaj Mandi, thence going alongwith Nohar road up to Railway Crossing road on Nohar road, which is the point of start.
- Ward No. 16 :- Starting from Panchmukhi chowk to sirsa road on right side up to Junction of street of Vishawkarma Mandir, thence going alongwith right side of above said road up to Nohar road in front of Ramdev Mandir, thence going alongwith right side of above said road up to Nohar road Railway crossing, thereafter going alongwith above said point up to Railway Station, thence going alongwith above said point to Old Railway Road in front of C.H.C., thence going alongwith above said point to Mameran Chowk,

thence going alongwith above said chowk to Panchmukhi chowk (Right side), Which is the point of start.

- Ward No. 17 :- Starting from the point where meet the Western & Northern M.C. Boundary and going alongwith northern side of M.C. Boundary up to point of where meet up to Canal, thence going alongwith above said Canal up to Handpump, thence going alongwith above said Hand Pump to Firni Road, thereafter going alongwith Firni road to Junction of Hanumangarh road, thence going alongwith above said road to Junction of Deshraj Dhani, thence going alongwith above said road to front point of Banwari Talwaria, thereafter going alongwith above said road up to Junction of Hanuman Nai, thence going alongwith above said road up to Junction of Street of Ramdev Mandir, thence going alongwith above said road up to point of street of Bhadu Wali, thence going alongwith above said road and old kothi up to Junction of Railway road, thence going alongwith above said road up to point of Water Work wall front up to Grover Hotel, thereafter going alongwith above said wall up to Railway station, thence going alongwith northern side of Railway Station & cross the Canal up to Junction of Hanumangarh Road, thereafter going alongwith above said railway line up to point of front side of Canal where meet the Western side of M.C. Boundary, thence going alongwith above said side up to point of where it meet & the Northern side of M.C. Boundary, Which is the point of start.
